Payment Terms : Full payment within 30 days from the date of receipt of material at our Silvassa plant. However, vendors offering higher credit period days would get an

advantage in terms of interest credit in calculating the landed cost of additives. Interest credit amount will be calculated at prevailing internal BL rates.

Packing : The materials are to be packed in brand new MS barrels with proper marking on it for identification.

GST : The Bidders should clearly mention rate of GST (as applicable) with HSN No, Freight charges for door delivery and any other charges separately.

Note : The vendor should compulsorily follow all the provisions of GST law and in the event of any default of complying with any of the provisions of GST law Balmer Lawrie would exercise the right for non payment or withholding payment or black listing the vendor.

Validity : Offer must be valid for our acceptance for 30 days from the due date of the tender.

Acceptance of Offer : BL reserves the right to reject any / all tenders if a conflict of interest between bidder and BL is detected at any stage.

Basis of Selection :

There will be no part / split order. 100% order/s will be placed grade wise L1 bidder only. The L1 rate will be arrived based on nett additive treat cost after considering input tax credit & base oil credit & input interest credit for the free credit period days offered by the bidder.

CONDITIONS FOR ONLINE BID SUBMISSION

1.0 Procedure for Bid Submission

The bidder shall submit his response through bid submission to the tender on e-procurement platform at <https://balmerlawrie.eproc.in> by following the procedure given below. The bidder would be required to register on the e-procurement market place at <https://balmerlawrie.eproc.in> and submit their bids online. No offline bids shall be entertained by the Tender Inviting Authority. The bidders shall submit their eligibility and qualification documents, Technical bid, Financial bid etc., in the standard formats prescribed in the Tender documents, displayed in e-procurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., if required, in support of their eligibility criteria/technical bids in the e-procurement web site. However, bulky documents need not be scanned and uploaded but physical copy of the same should be sent to the Tender Inviting Authority office before the tender opening date. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.

2.0 Registration with e-procurement platform

4.0 **Submission of Hard copies**
