GENERAL TERMS & CONDITIONS

1. Scope of work

- a) Arranging for 120 MT cranes to offload an Equipment of 47MTS from Trailer and move to Respective Yard/Location at Marathahalli, Bangalore.
- b) Providing Helpers/ Labours for unlashng , support during Offloading with proper safety measurements such as helmets, shoes etc.,

Dimension of PKG - 375 x 205 x 180 CM – 47 MTS

A) Tasks & responsibility

- a. The vendor should place crane at offloading point as per our requirement. In the event of their failure to do so , the company reserves the right to impose penal charges @Rs 2000/-per day per vehicle for delay in placement.
- b. In case of failure of the contractor to place required vehicles on time/arrange crane. BL reserves the right to utilize the services of any other transporter without notice at the risk and cost of the contractor and to recover charges and expenses in excess of the contractual obligations , the work shall be completed at the risk of the contractor and cost through alternative source /arrangements. This will be without prejudice to the right of BL for any other action including termination.
- c. The contractor should follow all the applicable rules & regulations of the concerned authorities. Any penalty due to violation of any rule would be to the contractors account.
- d. While handling the shipment is in the custody of the contractor, the contractor should take all precautionary measures including safety and security of the shipment.
- e. The contractor should provide proper superintendence during loading/unloading of shipment shall coordinate with the for smooth execution of the job.

- f. Contractor shall deal with all local problems and sort-out amicably & peacefully. Any matter requiring intervention of Police should be done by contractor. In the process contractor should ensure that container and cargo therein are fully protected against any demurrage, pilferage

B) Evaluation of Bids:

Lowest offer (L-1) shall be decided based on the aggregate value of all line items.

C) Contract Period & Commencement of work

The contract shall be for 1 Month period from the date of awarding the contract.

The work shall have to be commenced within 24 hours from the Intimation from our office..

D) Alternative Arrangement

In absence of timely and proper performance by the contractor, Balmer Lawrie reserves the right to utilize the services of any other contractor without notice at the **risk and cost** of the contractor and to recover charges and expenses in excess of the contractual terms from the contractor. Similarly if the contractor fails to meet their contractual obligations, the work shall be completed at their risk and cost through alternative sources/arrangements. This will be without prejudice to the rights of BL for any other action including termination, forfeiture of security deposit etc.

This contract also does not restrict the right of Balmer Lawrie to take recourse to the above conditions even if notice of termination is not served and contract terminated with the contractor

E) Force Majeure Conditions

If at any time during the continuance of the contract, the performance in whole or part by either party or obligation under the contract shall be prevented by reasons of any war, hostility, acts of public enemy, civil commotion, sabotage, fire not caused due to contractor's negligence, floods, explosion, earthquake, epidemics, quarantine, restrictions, strike, lock-outs, change in Government/Port/Customs policy or acts of Gods (hereinafter referred as events), then provide notice of the happenings of any such events is given by either party to the other within 15 days from the date of occurrence thereof, neither party shall by reasons of such events be entitled to terminate the contract nor shall either party have any claim for damage against the other in respect of such non-performance or delay in performance. The contract shall be resumed as soon as practicable after such events have come to an end or ceased to exit.

F) Billing & Payment

Payment will be made within 30 days from the date of submission of invoices.

G) Acceptance/rejection of the Tender

Balmer Lawrie reserves the right to accept or reject any or all tenders without assigning any reasons.

H) Settlement of disputes by Arbitration

Any dispute or difference arising under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Chairman and Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration & Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the Arbitrator, if any, shall be shared equally by both the parties.
